RE: 2015 Renewal Applications

Please note that **ALL** Licenses/Permits expire December 31st of each year. Enclosed is your 2015 renewal application. All applications must be **completely filled out** and returned with the proper fee to the Board of Health Office **on or before December 16, 2014**. **Any applications received after December 16, 2014 will incur a non-compliance fee of \$100.00 and you will not be licensed to legally operate in the Town of Grafton.** Also, please be sure to include your email address as **ALL applications will now be sent electronically.**

ATTN: SEPTAGE HAULERS

If your company applies for Portable Toilet Permits please use the enclosed application form.

ATTN: SOLID WASTE HAULERS

If your business is not in the following Zoning Districts (Neighborhood Business, Commercial Business, Office and Light Industry) you must enclose a copy of your Home Occupation Permit you received from the Building/Zoning Department. Failure to enclose this copy will also result in delay of issuance of your 2015 license (Grafton businesses only).

TO: Septic System Installers
FROM: Board of Health
RE: Field Changes

This is a reminder that Grafton's Supplemental Regulations to Title V prohibit **ANY** field changes without written authorization **of both the designer and the Board of Health**. This includes moving the septic tank, moving the sewer line from the house, changing from a ninety degree to two forty five degree couplings, etc.

The procedure is as follows: the designer must fax a copy of the proposed change to the Inspector for review with an explanation for the requested change prior to the work being done. The Inspector will then notate in the file the approval as well as notify the installer that the installation can proceed with the approved change(s).

Any unauthorized field changes for any reason will result in a non-compliance fee of **\$100.00** per day per violation to **both** the installer and the designer, since it appears in most cases the designer is being consulted and not following through with the Board of Health.

Note: Grafton's Supplemental Regulations to Title V are available on our website at www.grafton-ma.gov as well as a hard copy in the office. It is your responsibility to be familiar with them as well as to comply.

Information and Instructions

Massachusetts General Laws chapter 152 requires all employers to provide workers' compensation for their employees. Pursuant to this statute, an *employee* is defined as "...every person in the service of another under any contract of hire, express or implied, oral or written."

An *employer* is defined as "an individual, partnership, association, corporation or other legal entity, or any two or more of the foregoing engaged in a joint enterprise, and including the legal representatives of a deceased employer, or the receiver or trustee of an individual, partnership, association or other legal entity, employing employees. However, the owner of a dwelling house having not more than three apartments and who resides therein, or the occupant of the dwelling house of another who employs persons to do maintenance, construction or repair work on such dwelling house or on the grounds or building appurtenant thereto shall not because of such employment be deemed to be an employer."

MGL chapter 152, §25C(6) also states that "**every state or local licensing agency shall withhold the issuance or renewal of a license or permit to operate a business or to construct buildings in the commonwealth for any applicant who has not produced acceptable evidence of compliance with the insurance coverage required.**"

Additionally, MGL chapter 152, §25C(7) states "Neither the commonwealth nor any of its political subdivisions shall enter into any contract for the performance of public work until acceptable evidence of compliance with the insurance requirements of this chapter have been presented to the contracting authority."

Applicants

Please fill out the workers' compensation affidavit completely, by checking the boxes that apply to your situation and, if necessary, supply your insurance company's name, address and phone number along with a certificate of insurance. Limited Liability Companies (LLC) or Limited Liability Partnerships (LLP) with no employees other than the members or partners, are not required to carry workers' compensation insurance. If an LLC or LLP does have employees, a policy is required. Be advised that this affidavit may be submitted to the Department of Industrial Accidents for confirmation of insurance coverage. **Also be sure to sign and date the affidavit.** The affidavit should be returned to the city or town that the application for the permit or license is being requested, not the Department of Industrial Accidents. Should you have any questions regarding the law or if you are required to obtain a workers' compensation policy, please call the Department at the number listed below. Self-insured companies should enter their self-insurance license number on the appropriate line.

City or Town Officials

Please be sure that the affidavit is complete and printed legibly. The Department has provided a space at the bottom of the affidavit for you to fill out in the event the Office of Investigations has to contact you regarding the applicant. Please be sure to fill in the permit/license number which will be used as a reference number. In addition, an applicant that must submit multiple permit/license applications in any given year, need only submit one affidavit indicating current policy information (if necessary). A copy of the affidavit that has been officially stamped or marked by the city or town may be provided to the applicant as proof that a valid affidavit is on file for future permits or licenses. A new affidavit must be filled out each year. Where a home owner or citizen is obtaining a license or permit not related to any business or commercial venture (i.e. a dog license or permit to burn leaves etc.) said person is NOT required to complete this affidavit.
