Comments:

The police department has no objections to the proposal for an outdoor dining area (tent) with the following conditions:

- The tent, is sufficiently contained so that there is only one entrance/exit (subject to building and fire code) so patrons cannot leave the premises with alcoholic beverages (unless wine or malt beverages in original sealed containers sold with food as per ABCC regulations.)
- Containment may include, tent walls, temporary/permanent fencing, barricades, potted shrubbery or some other form of barrier to separate and delineate the outdoor dining area from the street or parking lot.
- Management shall provide constant monitoring of the outside dining area to ensure patrons do not leave the premises with alcoholic beverages except as specified above.
